### **Cannabis Production**

To Whom It May Concern:

BioSafe Systems has been approached for documentation of approval from PMRA, CFIA or Health Canada pertaining to the use of its products in cannabis production. In the majority of cases these agencies do not provide specific approval related to the use in cannabis.

SaniDate 5.0 (DIN# 02354594) is approved for the use patterns as indicated on the label by CFIA and Health Canada for the sanitization and disinfection of various hard surfaces such as equipment and tools, when used according to the label directions for use. Additionally, SaniDate 5.0 must not be sprayed directly on cannabis plants.

ZeroTol (PCP # 29508) is approved for the suppression of Powdery Mildew and Botrytis on cannabis (marihuana) plants produced commercially indoors and for the treatment of greenhouse surfaces and equipment when used according to the label directions for use.


Should any changes occur in the chemical formulation, or in the labelling format of the aforementioned non-food chemical, then this acceptance will be considered **NULL and VOID**.
